### Career Connections Program Updates – Tammie Lilly / Jayme Arndt

Jayme Arndt presented the monthly numbers for In-School (IS) and Out-of-School (OS) participants served.

She shared that sometimes the enrolling process is slow, depending on the time of year and the events that surround it (graduations, breaks, etc.). She stated that enrollment would pick back up in the next couple of months. They have been working hard on enrollment in counties where the numbers are lowest, but the need is great for such services, such as in Monroe, Nicholas, and Wyoming counties.

Jayme also shared the number for the students that are participating in the Paid Work Experience (PWE) program. She drew attention to the packet, which provided details of the positions and placements of the youth.

The "Who Am I?" workshop was held last month. This workshop is designed to help the students figure out who they are in their own worlds and what they may want to do with their lives. She stated that so many youths are so used to doing nothing and having little to no expectations from others or for themselves. This workshop helps in a continual process of encouraging and enabling students and young adults to do better and be better for themselves and the world they live in.

Tia asked Jayme if the students ever come together for workshops or events that may be added to the calendar. Jayme shared that a variety of projects and presentations happen throughout the year, and that those in the program can be gathered together for such events multiple times in the program year.

Tammie Lilly asked Tia if JobCorps would like to present what they can offer youth and suggested that they participate in the Career Connections end of the year event. The day is filled with learning and most in the program will be in attendance. Tia thanked Tammie for the opportunity and said that JobCorps would enjoy the opportunity to be a part of that day. Tammie said that she would forward information with the details as they are established.

Tammie shared that Career Connections has partnered with Academy of Careers & Technology (ACT) in a beautification project. ACT has provided giant, hand-made planters that will be set up outside of each career center in Region 1. The youth in the Career Connections program will be in charge of the filling and upkeep of the planters. This is a wonderful partnering opportunity, as well as teaching the youth about care for the community.

**Comments / Other Business**

Tammie thanks the Region 1 Workforce Development Board (R1WDB) for allow the youth that were in the Pathfinders program to be transitioned to the Career Connections program. The youth have greatly benefited from the extra year of counseling, events, and workshops.

Tia shared that JobCorps is actively recruiting youth for their program. If anyone is interested or knows a youth that would benefit from their services, please contact JobCorps.
