Welcome – Tammie Lilly

Connections Monthly Program Overview – Tammie Lilly

Tammie shared that this is the time of the year that Paid Work Experiences (PWE) is high for the youth program. 20% of all youth monies have to be used for PWEs. She said that they will easily meet that goal.

The Pathfinders staff members have been transferred to the Career Connections program. This transition will allow the Connections Program to be able to serve approximately 120 In-School (IS) youth. With the Out-of-School (OS) youth, there is a lot more one-on-one taking place, which seems to work best for meetings.

Jayme shared about an OS youth that is going through a particularly difficult ordeal to be in the program and succeed in life. Tia asked for a bit more details and possibly partnering and getting him further assistance through JobCorps.

Tammie said that similar situations with OS youth not having a home, food, etc. have become more prevalent. Alyce offered more information that could be beneficial to the youth in the program.

Tammie thanked everyone for their input and if they further information that could be helpful, to send it to her email.

Jayme went over the numbers as they stood since June 2017.

Tia drew attention to the fact that the Career Connections program has been constantly meeting and surpassing their goals. Tammie said that word of mouth has been the primary way of recruitment, both IS and OS.

Tammie said that they will be starting on their collections for Holiday Connections. She said they have to start early, because it takes time to organize and gather as many things they need for all the youth in the program.

Tia asked if there were any additional comments or business that anyone would like to share at the time.

Tia said that there will be tours available on the 2nd and 4th Wednesdays @ 10am at the Charleston Job Corps Center. She there will also be an open house Thursday evening session @ 6pm for those who cannot attend in the day time.

Tia asked how ROSS IES has been fitting into their new role as One-Stop Operator for Region 1. Tammie stated that there have been people hired and things are very busy, but going very well so far.

More discussion happened concerning One-Stop operations, and changes happening for other organizations on presentation and customer service.
